The base goal projection after weighting is as follows:

- Total Weighted DBE Availability: **\$75,018**
- Total for All Trades: \$8,190,725

Dividing the weighted DBE totals by the total estimate for all trades gives a base DBE availability figure for the projects anticipated during the goal-setting period. This figure is expressed as a percentage and serves as the basis for the three-year overall goal.

Base of DBE Goal: 0.9%

### Step 2: Adjustments to Step 1 base figure

### Past History Participation

One piece of data used to determine the adjustment to the base figure was the median of historical DBE accomplishments, as follows:

Arranging this historical data from low to high (0%, 2.6%, 4.9%), the median is **2.6%**.

Step 1 Base averaged with historical median: (0.9% + 2.6%) / 2 = 1.8%

To arrive at an overall goal, the Step 1 base figure was added to the Step 2 adjustment figure and the total was averaged, arriving at an overall goal of **1.8%**. City of Pueblo believes this adjusted goal accurately reflects DBE participation that can be achieved for the type(s) of work being awarded during this three-year goal period (FY 2024-26).

# Breakout of Estimated "Race and Gender Neutral" (RN) and "Race and Gender Conscious" (RC) Participation

The Pueblo Memorial Airport will meet the maximum feasible portion of the overall goal by using race neutral means of facilitating DBE participation.

- 1. Arranging solicitations, times for the presentation of bids, quantities, specifications, and delivery schedules in ways that facilitates DBE, and other small businesses, participation;
- 2. Carrying out information and communications programs on contracting procedures and specific contract opportunities;
- 3. Ensuring distribution of DBE directory, through print and electronic means, to the widest feasible universe of potential prime contractors;

Pueblo Memorial Airport estimates that in meeting the established overall goal of **1.8%**, it will obtain **0.8%** from RN participation and **1.0%** through RC measures.

This breakout is based on:

In FY 21 and FY 23, Pueblo Memorial Airport accomplishments exceeded the goal by 1.0% and 0.9%, respectively, which may be construed as evidence of race-neutral participation. Therefore, 0.8% of the 1.8% goal is expected through race-neutral means and the remaining 1.0% is to be obtained by race-conscious measures.

Pueblo Memorial Airport will adjust the estimated breakout of race neutral and race conscious DBE participation as needed to reflect actual DBE participation (see §26.51(f)) and track and report race neutral and race conscious participation separately. For reporting purposes, RN DBE participation includes, but is not necessarily limited to the following: DBE participation through a prime contract obtained through customary competitive procurement procedures; DBE participation through a subcontract on a prime contract goal, and DBE participation on a prime contract exceeding a contract goal, and DBE participation through a subcontract from a prime contract of that did not consider a firm's DBE status in making the award.

## **Consultation**

In establishing the overall goal, the Pueblo Memorial Airport provided for consultation and publication. This process included consultation with minority, women's, and general contractor groups, community organizations, and other officials or organizations which could be expected to have information concerning the availability of disadvantaged and non-disadvantaged businesses, the effects of discrimination on opportunities for DBEs, and the

City of Pueblo's efforts to establish a level playing field for the participation of DBEs. The consultation included a scheduled, direct, interactive exchange with as many interested stakeholders as possible focused on obtaining information relevant to the goal setting process, and was conducted before the goal methodology was submitted to the operating administration for review. Details of the consultation are as follows.

The consultation engaged in was a teleconference (via Zoom), which was held on July 10, 2023, at 12:00 pm.

No comments were received during the course of the consultation meeting

A notice of the proposed goal was published on the Airport's official website (**www.flypueblo.com**) before the methodology was submitted to Federal Aviation Administration.

If the proposed goal changes following review by Federal Aviation Administration, the revised goal will be posted on City of Pueblo official website.

Notwithstanding paragraph (f)(4) of §26.45, City of Pueblo proposed goals will not be implemented until this requirement has been met.
